**Sydney Metro – Sydenham to Bankstown (SSI 8256)  
Hurlstone Park, Belmore and Wiley Park Station Upgrades (Package 6)  
Construction Environmental Management Plan (CEMP) and sub plans**

I refer to your submissions requesting approval of the Construction Environmental Management Plan (CEMP), Construction Heritage Management Sub Plan (CHMP), Construction Noise and Vibration Management Sub Plan (CNVMP) and Construction Soil and Water Management Sub Plan (CSWMP) for the Hurlstone Park, Belmore and Wiley Park Station Upgrades, in accordance with Conditions C1-C7 of SSI 8256.
