Welcome to the first edition of our First Nations Business Newsletter, created to help First Nations-owned businesses connect with the Queensland Train Manufacturing Program (QTMP).

QTMP knows that First Nations businesses are a great under-utilised source of economic growth for the Australian economy. We are committed to building a diverse supply chain for the benefit of all.

This quarterly update will provide support and advice for First Nations-owned businesses on how to tap into opportunities to provide goods and services to QTMP. It will include information about upcoming events, networking opportunities and resources. We'll also showcase and celebrate First Nations suppliers and employees working on the project.

We believe a strong, diverse and self-supporting First Nations business sector is key to empowering Aboriginal and Torres Strait Islander peoples. It places First Nations business owners, their families, and communities in the driver's seat of their economic future.

# **The Project**

The QTMP was established to meet the increasing demand for rail transport in South East Queensland over the next 10 years.

The program will build 65 new six-car passenger trains at a purpose-built manufacturing facility at

Torbanlea, on Butchulla Country in the Fraser Coast region.

A new rail facility site will also be constructed at Ormeau in the Gold Coast region, home to the Yugembeh Language Speaking Peoples.

In June 2023, Downer was awarded the contract to build the two facilities, manufacture the trains and operate and maintain the fleet for 15 years.

QTMP will boost local supply chains, engaging Queensland businesses to supply goods and services such as:

- Site establishment works
- Civil and structural works
- Building and utility services
- Rail infrastructure
- Site services
- Site commissioning.

# HRC Supporting Engagement with First Nations Australian Businesses

The Hyundai-Rotem Corporation (HRC) is establishing a \$30 million facility on the Fraser

Coast to produce sub-components for train car bodies. HRC is Downer's technology partner for QTMP.

HRC is committed to supporting First Nationsowned businesses who want to supply goods and services to QTMP's rollingstock packages. The packages are primarily for the supply of fabricated components and welded assemblies, as well as electrical systems and subassemblies.

The company has been encouraged by the level of engagement, the capacity and wide-ranging capabilities of the businesses it has had conversations with so far.

HRC encourages all First Nations-owned businesses interested in supplying goods and services to the QTMP project to register with <u>Supply TMR</u>.

## Specialist advisors

Downer and its subcontractors will engage more Aboriginal and Torres Strait Islander business specialists like Rebecca Burke to support First Nations-owned suppliers. They will be an important touch point for businesses to connect with for guidance on supplying to QTMP.

To help First Nations businesses navigate the sometimes complex process of being engaged on a major project, Downer and its subcontractors are offering the following support:

- Additional lead time to prepare and submit tender and EOI documents
- Preferential payment terms for First Nations-owned businesses\*
- Training on how to prepare tender submissions. Details to follow soon.

#### **Supply Nation**

Being a registered or certified supplier with <u>Supply Nation</u> means being part of Australia's largest national directory of Aboriginal and Torres Strait Islander businesses. It's the first step to connecting with organisations who want to work with First Nations-owned businesses.

QTMP is working with <u>Supply Nation</u> and the <u>Department of Treaty</u>, <u>Aboriginal and Torres</u> <u>Strait Islander Partnerships</u>, <u>Communities and</u> <u>the Arts</u> (DTATSIPCA) to advise First Nations businesses of opportunities on the project.
